## **CALL TO ORDER**

Ms. Hobbs called the meeting to order

## **PRESIDIO PHONE SYSTEM PRESENTATION – JAMIE SNIDER**

Mr. Snider showed the Board an aerial view of the County and explained where the phone lines and fibers would be placed and stated some are already in place. Mr. McKlarney explained the system will actually pay for itself over a 5 year term. There would be no additional long distance services required which would be a tremendous savings for the entire County. He stated an estimated \$40,000.00 is already required to replace our current switches and the core to begin this process is \$39,973.75. Mr. McKlarney explained over a five year term the County would have a savings of \$187,000.00. Mr. Snider explained the lease payment for the phone system will be \$3,118.15 per month and we already pay Verizon over \$3,200.00 monthly. Mr. McKlarney explained that staff needs permission to move forward with signing the lease.

***Mr. Williams motioned to sign the lease agreement for the Presidio Phone System in the amount of \$3,118.15 per month for five years and Mr. Baker seconded the motion. The motion was approved 4-0 as follows:***

## **PURCHASE OF BORING MILL**

Mr. McKlarney explained Mr. Belcher had located a boring machine in Tazewell, Virginia and would like the Board to consider this purchase. Mr. McKlarney stated we offered \$35,000.00 for the machine and a counter offer was made for \$40,000.00. Mr. McCoy stated this is still a good price and the machine will be a good asset.

***Mr. McCoy motioned to purchase the boring machine for an amount of \$40,000.00 and Mr. Baker seconded the motion. The motion was approved 4-0 as follows:***

## EXECUTIVE SESSION

Mr. Baker seconded the motion.*

## REASSESSMENT

There was discussion regarding the 2014 reassessment. Mr. McKlarney stated the overall property assessed had a total value of \$1,078,147,800.00 and in 2015 it was \$1,037,182,500.00 which is an estimated \$40,000,000.00 decrease. He explained the Celanese Boiler has not hit yet and when this happens it will actually drop to \$57,000,000.00 decrease. Mr. McKlarney stated this is an overall decrease in values overall of 5.3%. Mr. McKlarney explained he has not received 2015 land use but using the 2014 numbers there is an overall decrease in value of \$134,000,000.00 which is a \$726,000.00 decrease in taxes. The Board discussed possible tax increased but an amount was not determined.

Mr. McKlarney explained that Mr. Spencer had sent in a request for the County to assist with an alternate water and sewer system at the Glen Lyn Park. Mr. McKlarney explained the Board agreed to assist but a formal motion was required.
