ORDER AND WRIT FOR SPECIAL ELECTION

THIS MATTER came to be heard upon the Petition of the Town of Pearisburg, Virginia, pursuant to Va. Code Ann. §24.2-226 for the issuance of a writ for a special election to the office of Member of Town Council of the Town of Pearisburg, Virginia.

The Court has determined as follows:


1. That the Town of Pearisburg, Virginia, is located within the county of Giles thereby conferring jurisdiction upon this Honorable Court;
2. That Colin D. Munsey was elected as a Member of Town Council of the Town of Pearisburg, Virginia, for a four-year term, ending on December 31, 2019; and,
3. That Colin D. Munsey, has in fact resigned from said office of Member of Town Council of Pearisburg effective November 30, 2016, thereby causing a vacancy in the office of Member of Town Council of the Town of Pearisburg;
4. Pursuant to Va. Code Ann. §24.2-226, the next general election to fill the vacancy by election is November 7, 2016.

Accordingly, it is ADJUDGED and ORDERED:

1. That a writ for special election for the office of Member of Town Council of the Town of Pearisburg, Virginia, shall issue and said election shall be held on November 7, 2017, for a term expiring on December 31, 2019.
2. That a certified copy of this Order shall be transmitted by the Clerk of this Court to the Giles County General Registrar and to the State Board of Elections.

And this matter is ended and stricken from the Active Docket of this Court.
