

# **2022 Annual Water Quality Report - Giles County Wolf Creek System PWSID #1071970 (Includes Residents of Marlville)**

## **Is my water safe?**

We are pleased to present this year's Annual Water Quality Report (Consumer Confidence Report) as required by the Safe Drinking Water Act (SDWA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies.

## **Do I need to take special precautions?**

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

## **Where does my water come from?**

Your drinking water comes from two groundwater wells; Well #1 located on the Giles County PSA Water Treatment Plant property and Orchard Well, located within the Town of Narrows.

## **Source Water Assessment and its Availability**

The Virginia Department of Health performed Source Water Assessments of both Well #1 and Orchard Well in 2020 and found them to be of high susceptibility to contamination using the criteria developed by the state in its approved Source Water Assessment Program. The assessment report consists of maps showing the source water assessment area, an inventory of known land use activities of concern, and documentation of any known contamination within the last five (5) years. The reports are available by contacting your water system representative at the phone number or address given elsewhere in this drinking water quality report.

## **Why are there contaminants in my drinking water?**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800-426-4791). The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity:

- Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;

- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming;
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses;
- Organic Chemical Contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems;
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

### **How can I get involved?**

### **Description of Water Treatment Process**

The portion of your drinking water that comes from Well #1 is processed via direct filtration through a membrane filtration plant. A small amount of chlorine is used to kill bacteria and other microorganisms (viruses, cysts, etc.) that may be in the water before water is stored and distributed to homes and businesses in the community.

The portion of your drinking water that comes from Orchard Well is treated by disinfection. Disinfection involves the addition of chlorine to kill dangerous bacteria and microorganisms that may be in the water. Disinfection is considered to be one of the major public health advances of the 20th century.

### **Water Conservation Tips**

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference - try one today and soon it will become second nature.

- Take short showers - a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save you up to 750 gallons a month.
- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.
- Fix leaky toilets and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank and wait. If it seeps into the toilet bowl without flushing, you have a leak. Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.

- Adjust sprinklers so only your lawn is watered. Apply water only as fast as the soil can absorb it and during the cooler parts of the day to reduce evaporation.

### **Cross Connection Control Survey**

The purpose of this survey is to determine whether a cross-connection may exist at your home or business. A cross connection is an unprotected or improper connection to a public water distribution system that may cause contamination or pollution to enter the system. We are responsible for enforcing cross-connection control regulations and insuring that no contaminants can, under any flow conditions, enter the distribution system. If you have any of the devices listed below please contact us so that we can discuss the issue, and if needed, survey your connection and assist you in isolating it if that is necessary.

- Boiler/ Radiant heater (water heaters not included)
- Underground lawn sprinkler system
- Pool or hot tub (whirlpool tubs not included)
- Additional source(s) of water on the property
- Decorative pond
- Watering trough

### **Source Water Protection Tips**

Protection of drinking water is everyone's responsibility. You can help protect your community's drinking water source in several ways:

- Eliminate excess use of lawn and garden fertilizers and pesticides - they contain hazardous chemicals that can reach your drinking water source.
- Pick up after your pets.
- If you have your own septic system, properly maintain your system to reduce leaching to water sources or consider connecting to a public water system.
- Dispose of chemicals properly; take used motor oil to a recycling center.
- Volunteer in your community. Find a watershed or wellhead protection organization in your community and volunteer to help. If there are no active groups, consider starting one. Use EPA's Adopt Your Watershed to locate groups in your community, or visit the Watershed Information Network's How to Start a Watershed Team.
- Organize a storm drain stenciling project with your local government or water supplier. Stencil a message next to the street drain reminding people "Dump No Waste - Drains to River" or "Protect Your Water." Produce and distribute a flyer for households to remind residents that storm drains dump directly into your local water body.

### **Other Information - Sodium**

There is presently no established standard for sodium in drinking water. Water containing more than 270 ppm of sodium should not be used as drinking water by those persons whose physician has placed them on a moderately restricted sodium diet. Water containing more than 20 ppm should not be used as drinking water by those persons whose physician has placed them on a severely restricted sodium diet. For informational purposes, we wish to point out that the results of our most recent sampling (2019 – Well #1; 2020 – Orchard Well) indicate that your water has a sodium content range of 1.61 ppm (Well #1) to 4.92 ppm (Orchard Well).

## Monitoring and Reporting Violations

On January 4<sup>th</sup> and February 14, 2023, the Giles County Public Service Authority (GCPSA) was issued Notices of Violation (NOV) by the Virginia Department of Health Office of Drinking Water (VDH ODW):

**MONITORING, ROUTINE, MAJOR (RTCR)** for failure to collect and analyze bacteriological samples for the months of November 2022 and December 2022, respectively. Routine bacteriological samples are used to monitor your drinking water for the presence of coliform bacteria. When found in drinking water, coliform bacteria – which are harmless – indicate that conditions are favorable for more harmful bacteria to grow, including E.Coli. Other samples collected in 2022 all tested negative for the presence of coliform bacteria and it is not believed that you were in any danger due to this oversight. No action on your part is necessary. See the section entitled, “Additional Information – Water Quality Data Table” elsewhere in this report for further explanation regarding these omissions.

On January 4<sup>th</sup> and January 25, 2023, the Giles County Public Service Authority (GCPSA) was issued Notices of Violation (NOV) by the Virginia Department of Health Office of Drinking Water (VDH ODW):

**MONITORING, ROUTINE (DBP), MAJOR** for failure to report chlorine disinfectant residuals for the months of November and December of 2022, respectively. The GCPSA Water Treatment Plant uses chlorine in the water treatment process in order to control microbes and protect against the presence of bacteria in your drinking water. The GCPSA is required to sample for the presence of and report the amounts of chlorine found in the water system and normally does so at the same time routine bacteriological samples are collected. Other samples collected in 2022 all tested for the presence of sufficient chlorine and it is not believed that you were in any danger due to this oversight. No action on your part is necessary. See the section entitled, “Additional Information – Water Quality Data Table” elsewhere in this report for further explanation regarding these omissions.

## Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Giles County Wolf Creek Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## Water Quality Data Table

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. The table below lists all of the drinking water contaminants that we detected during the calendar year of this report. Although many more contaminants were tested, only those substances listed below were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old. In this table you will find terms and abbreviations

that might not be familiar to you. To help you better understand these terms, we have provided the definitions below the table.

### Additional Information – Water Quality Data Table

At the end of September 2022, the GCPSA lost a key member of its operational staff and as a result, during the last quarter of 2022 (OCT – DEC) and into the first part of 2023, there was confusion about which required drinking water samples had and had not been collected. The Virginia Department of Health Office of Drinking Water (VDH ODW) notified the PSA that many of the required samples had not been collected during the 4<sup>th</sup> Quarter 2022 window during which they were to be collected. As a result, the table above (with the exception of Disinfectants & Disinfection By-Products and Turbidity) contains the results from 2021 – the most recent sample results available prior to the end of 2022.

The missing samples were collected early in 2023, the results of which were all within compliance limits and will be reported on next year’s Annual Water Quality Report.

\* Lead and Copper sampling is conducted every three (3) years, the next round of which will take place in 2023.
