**WRIT OF SPECIAL ELECTION**

**ON THIS DAY CAME** the Petitioner, Town Council for the Town of Narrows, Virginia, upon its Petition for Writ of Special Election filed herein, and petitioned the Court for a writ of special election ordering that a special election be held to fill the vacancy in the Town Council of the Town of Narrows, Virginia, pursuant to §§ 24.2-226, 24.2-228, and 24.2-682 of the Code of Virginia, 1950, as amended.

**UPON CONSIDERATION WHEREOF**, and the Court having found that the Petitioner is the local governing body of the Town of Narrows, Virginia; that Town council member, Bobby Lucas, resigned from his office, effective January 8, 2024; that, effective January 8, 2024, there exists a vacancy in the Town Council of the Town Narrows, Virginia; that pursuant to § 24.2-226 of the Code of Virginia, 1950, as amended, the Petitioner has petitioned the Court for a writ of special election to fill the vacancy for the remaining portion of the regular term of the office that will be left vacant by Mr. Lucas' resignation; that the Court finds it appropriate to issue the writ ordering that a special election be held on the date of the next general election on November 5, 2024, to fill the vacancy; and that it is otherwise proper to do so, it is hereby **ORDERED** as follows:

1. That the election officials of Giles County, Virginia, at the next general election, which will occur on November 5, 2024, open the polls and conduct a special election to fill the

vacancy in the Town Council of the Town of Narrows, Virginia, and for the winning candidate, duly elected and qualified, to serve the remainder of the regular term of the office left vacant by Mr. Lucas.

2. That the election officials of Giles County, Virginia shall perform such other duties as are necessary or required to accomplish the purposes of this Order, including providing notice of the special election to the public as required by Virginia Code § 24.2-683.

3. That certified copies of this Order shall be sent by the Clerk of this Court to the Narrows Town Attorney, the Giles County General Registrar, the Secretary of the Giles County Electoral Board, and the Secretary of the State Board of Elections.
